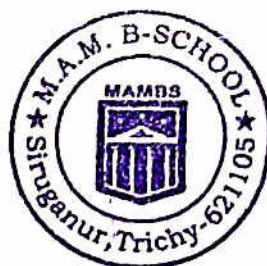
Extension of Agreement: The MOU may be extended, subject to the agreement of both parties and the availability of resources.

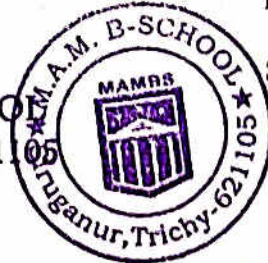

- III. The 'Party-2' would provide Skill Development Programmes (SDPs) for the students of Institution-1.
- IV. The institute and Academy may over the years expand the scope of this agreement on mutual consent.
- V. Funding:
- a) Expenses for transportation, room and board and personal expenses of exchange students, teachers or officers shall be covered by each party on their own.
 - b) There is no financial commitments between both the parties, to take up any programs or activities mentioned in the scope of MoU. If any financial commitments arise in future, it will be dealt separately with the mutual consent of both the parties.
- VI. No Employment Relationship:
The parties agree that this Agreement shall not be construed in any manner as establishing any kind of partnership or bond of a labour nature between them.
