### MEMORANDUM OF UNDERSTANDING (MoU)

The broad areas of collaboration are indicated below.

- I. The purpose of this MoU is to develop academic and educational cooperation and to promote mutual understanding between the two parties.
- II. Each parties agrees to develop the following collaborative activities in the academic areas of mutual interest, on a basis of equality and reciprocity.
  - a. Exchange of faculty and students for programmes and events organized and conducted by both the institutions.
  - b. Improving students' performance in competitive exams, enhancing their skills, or increasing access to coaching services.
  - c. Conducting collaborative seminars, conferences and organizing symposium, management meets, etc.
  - d. Exchange of academic and study materials, including textbooks, study guides, practice papers, and online resources materials.
  - e. Promoting collaboration in fields of mutual interest.
  - f. Promoting any other academic cooperation as mutually agreed.

III. The 'Party2' would provide Skill Development Programmes (SDPs) for the students of Institution-1.



IV. The institute and Academy may over the years expand the scope of this agreement on mutual consent.

V. Funding:

- a) Expenses for transportation, room and board and personal expenses of exchange students, teachers or officers shall be covered by each party on their own.
- b) There is no financial commitments between both the parties, to take up any programs or activities mentioned in the Scope of MoU. If any financial commitments arise in future, it will be dealt separately with the mutual consent of both the parties.


VI. No Employment Relationship:


The parties agree that this Agreement shall not be construed in any manner as establishing any kind of partnership or bond of a labour nature between them.




This Memorandum of Understanding shall come into effect from the date and time of its execution. Both the institutions have read and understood the contents of the agreement and agrees to be bound by the terms. This MoU will be in force for a period of **THREE** years and at the end of three years, it may be renewed for a further period based on mutual consent. Either party may terminate the Memorandum of Understanding at any time during the term by the provision of six months written notice to the other party.
