MEMORANDUM OF UNDERSTANDING (MoU)

BETWEEN

KUNTHAVAI NAATCCHIYAAR GOVT. ARTS COLLEGE FOR WOMEN(AUTONOMOUS),
THANJAVUR 613007, TAMIL NADU

AND

THANJAI MANAVALAKALAI MANRA TRUST (Centre for Yoga Spiritual Education)
THANJAVUR, 613007, TAMIL NADU

The Memorandum of Understanding (Hereafter called the MoU) is entered into on this the 30th day of August 2023, by and between Kunthavai Naatcchiyaar Government Arts College for Women (Autonomous), Thanjavur 613007, Tamil Nadu the first party represented herein by the Principal and Thanjai Manavalakalai Manra Trust(Centre for Yoga and Spiritual Education), Thanjavur 613007, Tamil Nadu the second party represented herein by the Managing Trustee

Whereas

- A) First Party is a Higher Educational Institution named Kunthavai Naatcchiyaar Government Arts College for Women (Autonomous), Thanjavur 613007, Tamil Nadu.
- B) Second Party is a Centre for Yoga and Spiritual Education named Thanjai Manavalakalai Manra Trust, Rajaappa Nagar, Thanjavur 613007, Tamil Nadu.
- C) First Party and Second Party believe that collaboration and cooperation between themselves will promote more effective use of each of their resources and provide each of them with enhanced opportunities.

- D) The Parties intent to cooperate and focus their efforts on cooperation with area of skill based training in Yoga and Kayakalpa.
- E) Dr. A. Radha, Assistant Professor of Zoology Kunthavai Naatechiyaar Government Arts College for Women (Autonomous), Thanjavur 613007 of the First Party and Prof. S.Poornachandran, Secretary, Thanjai Manavalakalai Manra Trust, Rajaappa Nagar, Thanjavur 613007 of the Second Party will be the nodal conduct persons for all the future correspondences. All communications will be addressed to the undersigned signatories with a copy to the respective nodal contact persons.

NOW THEREFORE IN CONSIDERATION OF THE MUTUAL PROMISES SET FORTH IN THIS MoU, THE PARTIES HERE TO AGREE AS FOLLOWS

CLAUSE 1 CO OPERATION

- 1.1 Both parties are united by common interests and objectives and they shall establish cooperation.
- 1.2 First Party and Second Party cooperation will facilitate effective utilization of the intellectual capabilities.
- 1.3 The Parties shall cooperate with each other and shall execute as promptly as is responsibly practical, relevant agreement.

CLAUSE 2 SCOPE OF THE MoU

- 2.1 **Visits:** This interaction will provide an insight into the latest developments requirements in the field of Yoga, the Second Party to permit the Faculty and Students of the First Party to visit their Yoga Centre and also involve in Practicum for the first party.
- 2.2 **Guest Lecture:** First Party to extend the necessary support to deliver Guest Lectures and organising workshop to the students and staff of the Second Party for best performance on Yoga.
- 2.3 **Training to the Students:** Second Party will help the training and the development of personality of the Students of the College of the first Party.
- 2.4 There is no financial commitment on both the Parties to take up any program / activities mentioned in the scope of MoU/ cooperation. If there is any financial consideration, it will be dealt separately.
- 2.5 Both Parties to obtain all internal approach, consents, permissions and licenses of whatsoever nature/ required.

CLAUSE 3 VALIDITY

This Memorandum of Understanding shall have duration of three years initially and renewable for further period, unless either party gives notice of termination not later than two months prior to the expiration of the existing MoU. However, either party can also terminate by giving notice of termination not less than two months, if this MoU turn out to unsustainable.

CLAUSE 4 RELATIONSHIP BETWEEN THE PARTIES

It is expressly agreed that First Party and Second Party are acting under the MoU as independent contractors, and the relationship established under the MoU shall not be constructed as a partnership.

Any dispute between the parties herein respect of this MoU and subsequent specific agreements shall be settled amicably through negotiation in good faith.
