In the reference 1st cited, the Secretary, University Grants Commission, New Delhi, has informed that the UGC has formulated the Guidelines on Determination of a uniform span period within which a student may be allowed to Qualify for a Degree and informed to implement the same to all affiliated colleges of (Autonomous/Non-Autonomous) this University.

In this regard, We have already sent a communication to all The Principals of Affiliated Colleges to implement the Uniform Span of Period vide this office letter 3rd cited.

Now, I am by direction to inform you that, the syndicate at its meeting held on 15.03.2018 resolved as follows:

- The candidates who admitted on or after 2018-2019 onwards be allowed to complete the UG/PG Programmes within two years from the completion of programme.
- In exceptional circumstance a further extension of one more year may be granted. The exceptional circumstances be spelt out clearly by the relevant statutory body concerned of the University.
- During the extended period the student shall be considered as a private candidate and also not be eligible for ranking.
- The UGC Guidelines should print in their Prospectus to be issued to the students along with the application form for admission.

The above matter may kindly be circulated to all the Head of Departments & Students of your College.


